THE SPECIAL SPEED LIMITS (AMENDMENT) (NO. 3) ORDER, 2018

1. This Order may be cited as the Special Speed Limits Citation (Amendment) (No. 3) Order, 2018.

2. The Special Speed Limits Order, 1979, is amended in the Schedule by inserting after item 19, the following new items:
